Upon telling his elderly adopted mother, she told him there was no money to buy replacement flip flops immediately.

When his teacher saw him bare foot, two days in a row, she asked what had happened and then went out at lunchtime to buy him new flip flops.

But God hadn't finished showing his love for Thiago. At our big family lunch, Thiago won a bicycle in our raffle. No one will forget the pure joy on this child's face as he ran forward to claim his prize. There is nothing more rewarding than being able to help children like him.
